

# Safe Burning Advice

The Heather and Grass etc. Burning (Wales) Regulations 2008

## Are you permitted to burn?

Is your farm covered by a management agreement? Some programmes will not allow for any type of burning. Breaching these rules may affect any payments you receive.

## The Burning Season

Upland areas - 1st October to 31st March.

Any other area - 1st November to 15th March.

You are not permitted to burn between sunset and sunrise.

## Area

Burn no more than 10 hectares in any single controlled burn. If your land lies on a slope of more than 45 degrees, then burn no more than 0.5 hectares in any single controlled burn.

## Controlled Burn

The safest way to conduct a controlled burn is to have three or more people involved.

–An active fire front should be no more than 5

to 10m per person depending on conditions.

## If you want to deviate from these regulations – you may need a licence!

This is issued by the Welsh Government Divisional Office.

## Burning Plan

All burning of land must be supported by a Burning Plan. Assistance in preparing a burning plan is available from your local Fire Service.

## Have you informed your local Fire Service and neighbouring land owners?

Confirm your intent to burn with a time, date and location. Preferably with a postcode or grid reference on:

## Llogi dan reolaeth

Llogi gyda thri neu ragor o weithwyr sydd fwyaf diogel – Ni ddylai ffrynt tân gweithredol fod yn fwy na 5 – 10m y person, gan ddiybnyu ar yr amodau.

## Os ydych chi eisiau gwyro oddi wrth y rheoliadau hyn – mae'n bosib fydd angen trwydded!

Cyflwynir trwyddedau gan Swyddfa Rhanbarthol Llywodraeth Cymru.
